- Company with an office in Mainland China:** Please attach your valid Chinese business license or the "Registration certificate of the representative office of foreign (regional) companies based in China" as a PDF or JPG file.
- Individual:** Please attach a scan or photocopy of your currently valid passport as a PDF or JPG file.

The cost of domain registration and management is EUR 60.00 per domain per year. The domain registration and management is automatically extended by a further 12 months unless it is terminated in writing no less than three months before the end of a contract year.

All our prices apply exclusively to industry, trade, crafts, commerce and public institutions. We do not accept orders from private customers. Subject to errors and technical changes. Our general terms and conditions apply exclusively. All prices are to be understood plus the German value-added tax (VAT), which is currently 19 %. The VAT will not be charged to companies from other EU countries if they do provide a valid VAT identification number on the order form. It will also not be charged to companies that are outside the European Union.
